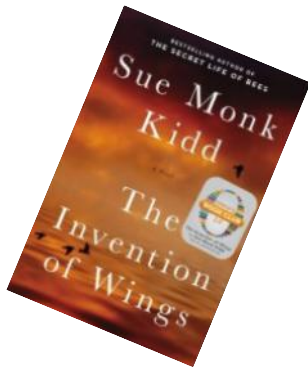
Sandy will be providing an updated list of the Officers, Committee Chairs and Special In

### CRUNCHY CHICKEN SALAD

- 3 tbs. butter or margarine
- 1 pkg (3 oz) Oriental-flavor ramen noodle soup mix
- 2 tbs. sesame seed
- 1/4 cup sugar
- 1/4 cup white vinegar
- 1 tbs vegetable oil
- 1/2 tsp. pepper
- 2 cups cut-up cooked chicken
- 1/2 cup dry-roasted peanuts
- 4 med. Green onions, sliced (1/4 cup)
- 1 bag (16 oz.) coleslaw mix

### EASY KEY LIME PIE

- 1 sm can frozen limeade juice
- 1 - 1/2/ gal good vanilla ice cream
- 2 ready made graham or vanilla pie crust

In a large bowl mix the ice cream and 3/4 can of the frozen limeade juice until well blended. Pour into the 2 pie crust and freeze. Take out of freezer a few minutes before serving. Serve with whipped topping & garnish with a lime circle.
